The Agenda Items for Consideration:

Item No. CVRU-IQAC-29A1:

Adoption of the Agenda & Verification of the Quorum

Item No. CVRU-IQAC-29A2:

Review and Approval of the minutes of the previous IQAC-meeting no.28, held on 8th January, 2021 and its Action taken Report.

Resolution: For reviewing the action taken report of the previous IQAC meeting, it was to resolve and approve the same by all the members present. The Action Taken report so approved was well communicated to all the members and circulated to all the concerned which was thereafter confirmed by all.

Item No. CVRU-IQAC-29A3:

Review & Approval of the various quality Audits conducted at CVRU such as AAA (Academic & Administrative Audit), Energy Audit, Waste Management Audit, Environment Audit, Green Audit & Curriculum Audit.

Resolution: For the quality upgradation, assessment and quality mandates of the University, several numbers of audits were successfully conducted in the University for certain areas towards specific fields of Energy, Environment, Academics & Administration viz. AAA, Energy audit, Eco-Audit, Curriculum audit, Environment audit, waste-management audit etc. Although due to covid-19 Pandemic some audits were processed in an online mode instead of physical visits. It was unanimously confirmed by all.

Review & Approval of the previous Reports of the admission committee & revision in fee structure.

Resolution: The final admission report and revised structure of the fee for regular programs and other courses was presented by the Director Admissions, Mr. Devendra Pratap Singh Yadav which was further discussed and resolved to be confirmed by all the members present.

Discussion on the Agenda Items for Reporting:

Item No. CVRU-IOAC-29A8:

Updates on the MoUs & MoAs signed by the University with HEI's, Industry & other Institutions of Repute for increasing & enhancing the academic support, academic-collaborations & industry linkage.

Resolution: It was discussed and reported by the University's MoU-coordinator Dr. Saurabh Mitra about the Collaborations as a number of MoU's were signed and Collaborations were made during the year. Keeping in view the industry needs of the students and to increase the industry-Academia linkage for enhancing the standards of academic collaborations, several MoUs & MoAs have been signed with industries as reported for Industry-Academia linkage by Dr. Rajiv Peters which was further kept in forth to be discussed and resolved to be approved by all the members present. This was further confirmed by all the members present.

Item No. CVRU-IOAC-29A9:

Updates on the Report of AQAR-2020-21, AISHE, and NIRF preparation, analysis & its Submission status.

Resolution: Discussion was made on the preparation of the data for submission of AQAR-2020-21, NIRF and AISHE and the details regarding the data collection, preparation, analysis, finalization & submission status was sought.
